The integrated tariffs above apply to professional low voltage customers with current of 50A or less per phase and include the grid usage tariff in force on the date shown at the top of the page. The grid usage tariff and fixed monthly grid access fee have been agreed under a regulation issued by the ILR (Luxembourg Energy Regulator). Subsequent modification of the network usage tariff will be passed on in the integrated tariffs.

The integrated tariff excludes VAT (8%), the fixed monthly grid access fee and all statutory levies such as the electricity tax and compensation fund (see grid access fee & Legal fees), which are set by the public authorities. They will be passed on by Enovos Luxembourg SA and shown in a transparent manner on your electricity bill.

nova naturstrom

In 2018 nova naturstrom will be provided by up to 55% out of national and regional production facilities (hydroelectric, wind power, biomass, photovoltaic). The remaining 45% will be provided by new EU renewable energy production facilities. The surcharge for supply of premium green electricity is unchanged at **0.0035 €/kWh (excluding VAT)**.

Grid access fee & Legal fees

Monthly grid access fee

The fixed monthly grid access fee varies according to the transmission capacity and covers for:

- Administrative and management fees as well as the provisioning of required transmission capacity for power consumption and production feed in.
- Charges in relation to the metering activity, as the acquisition and provisioning of metering data, data management and billing.

The monthly grid access fee varies in relation to the installed transmission capacity

The monthly grid access fee is part of the regulated grid connection fees to be submitted to the Luxembourgish Regulating Authority ILR for approval.

For low voltage grid users without power production facilities or with only a production facility:
